Ek, die ondergetekende:-

## Conditions :

I, the undersigned:-

1. Bevestig dat die besonderhede hierin uiteengesit korrek is en onderneem om DDKK in kennis te stel in die geval van verandering van my adres of ander besonderhede.
2. Onderneem om alle fooie en uitgawes vir dienste gelewer op aanvraag aan DDKK te betaal.
3. Neem kennis dat DDKK nie krediet voorsieners i.t.v. die Nasionale Kredietwet 34 van 2005, is nie en ek onderneem om alle rekeninge op aanvraag/by ontvangs daarvan te vereffen. In geval ek in versuim is en enige rekening aan my, nie binne 30 dae vanaf datum daarvan ten volle betaal is nie, dan stem ek toe dat ek aanspreeklik sal wees vir rente teen 2% per maand sowel as alle koste en uitgawes aangegaan om betaling van my rekening te bewerkstellig, op die skaal soos tussen prokureur en eie kliënt.
4. Kies my adres op die keersy uiteengesit, as adres waar ek alle kennisgewings en regsdokumente sal ontvang.
5. Bevestig dat alle fooie gehef word soos op die skaal tussen prokureur en eie kliënt en ek aanvaar aanspreeklikheid vir die betaling daarvan.
6. Bevestig dat ek geregtig is om enige rekening gelewer, te laat takseer, en onderneem om die getakseerde bedrag van die rekening te betaal, indien dit die gelewerde rekening te bowe gaan.

7. Consent to judgment i.t.o. Section 58 of Act 32 of 1944 for any amount due to DDKK outstanding for a period longer than 30 days and a certificate under the hand of any attorney of DDKK will be *prima facie* proof of my indebtedness.
